According to the Board of Directors' Meeting #14/2562 of I.C.C. International Public Company Limited, held on June 12, 2020, resolutions have been passed to carry out the following matters:

- 1. To inform the Annual General Meeting regarding the interim dividend payment for the company's performance from January 1 to December 31, 2019 at the rate of 0.70 Baht per share, with 290,633,730 shares, amounting 203,443,611.- Baht in total, or 29.26 percent of the Company's separate financial statement's net profit. The payment will be paid from the Company's retained profit deducted 30% from the corporate income tax; and it was already paid on May 7, 2020 to eligible shareowners whose names were listed on the record date of April 22, 2020 with right to receive dividend. In addition, the Board of Directors will not consider dividend payment for 2019.
- To set the date of the 55th Annual General Meeting 2020 on Monday of August 3, 2020 at 2:00 p.m. at the Galaxy Room, Avani+ Riverside Bangkok Hotel at 257 Charoennakorn Road, Samre Subdistrict, Thonburi District, Bangkok 10600 with following agenda:
 - To certify the previous minutes of the 54th Annual General Meeting 2019, held on Agenda 1 April 22, 2019.
 - To acknowledge the Annual Report of the Board of Directors and the Company Agenda 2 performance in 2019 which has been published in the Company's Annual Report.
 - Agenda 3 To consider for approval of the financial statements and reports of the auditor as of December 31, 2019.
 - To consider for approval the appropriation of the Company's profit and to Agenda 4 acknowledge the payment of 2019 interim dividend

The Board of Directors' Meeting also appointed the Chairman to be responsible to set or change date, time, and location of the Annual General Meeting by considering the necessity and appropriateness.

4. To approve the extension of guarantee facilities for Tokyu Corporation (Japan) to the Bank of Ayudhya Plc. for the Credit Line of Saha Tokyu Corporation Co., Ltd., in the proportion of investment of 61,260,000.- Baht, which is less than the previous credit line of 82,740,000.- Baht.

The previous credit line that Saha Tokyu Corporation Co., Ltd. received from Bank of Ayudhya Plc. as long-term and short-term loans, amounting 689.50 Million Baht in total, was guaranteed in full by Tokyu Corporation (Japan) and Saha Group's affiliated companies, as co-investors in Thailand, in 50:50 proportion, or 344.75 Million Baht. The Company, as one of the shareowners, joint guarantee based on the proportion of investment, amounting 82,740,000.- Baht.

The Saha Tokyu Corporation Co., Ltd. has gradually paid back 179 Million Baht for the long-term loan which leaves the long-term and short-term loans amounting 510.50 Million Baht. The remaining long-term loan is also adjusted to obtain the lowest interest rate possible. This credit line dues on May 29, 2020 and May 31, 2020. However the Saha Tokyu Corporation Co., Ltd. still requires the loan as its working capital which is within the following scope of related transactions:
